In 2024, 166 women were assisted when pregnancy-related financial challenges threatened their stability. Family homelessness and eviction were prevented. This critical program has immeasurable health benefits for both mother and child by providing shelter and promoting full-term pregnancies.
<b>4b</b>	(Code: ) (Expenses \$ 254,986 including grants of \$ 167,306 ) (Revenue \$ 170,342 ) Cradle of Hope's Safe Slumber program provides safe sleep education and distributes portable cribs to ensure that every baby has a safe place to sleep. In 2024, 2620 individuals received portable cribs and safe sleep training. As a result, infant mortality rates decrease. Mothers learn techniques to prevent accidental suffocation and strangulation in bed and how to lower the risk of SIDS (Sudden Infant Death Syndrome). They are equipped to provide a safe sleep environment for their babies, stress is alleviated, and they become more hopeful about their futures.
